1. Grants will be awarded to employees of the Avon Local School District, and/or residents of Avon working in cooperation with an Avon school employee to design and implement programs that will enhance and/or enrich instruction.
2. Grant requests will be competitive and awarded to single or multiple grantees.
3. Funds may be used to provide, but are not limited to:
 - a. Enrichment through resource speakers
 - b. Incentive and recognition programs
 - c. Projects to enhance student learning
 - d. Support for innovative teaching methods
 - e. Fine and performing arts
 - f. Self-esteem programs
 - g. Academic excellence scholarships
 - h. Parent education programs
4. Grant requests will be judged on the criteria listed on the Grant Application Rating Sheet, including:
 - a. Innovation
 - b. Number of students to benefit
 - c. Need for proposal
 - d. Cost effectiveness
5. All grant proposals shall be submitted to the Board of Trustees of the Avon School Educational Endowment Fund, 36600 Detroit Road, Avon, Ohio 44011, for evaluation.
